Sub : Recognition certificate under sub rule (4) of Rule 11 of free
and compulsory education of children rule 2011 for the
purpose of free and compulsory education Act 2009.

Sir/ Madam

With reference to the letter received from you and further
correspondence with school, I issue temporary recognition for class 3rd to
8th for 3 years from 1-4-2020 to 31-3-2023 in respect of Sri Guru
Harkrishan International school, Behrampur Road, Gurdaspur, Block
Gurdaspur-2.

This recognition will be subject to the fulfillment of the following
conditions :

1. Period of recognition cannot be extended and it is not agreeable to
extend recognition beyond class 8.
2. School will implement rule 2011 (Annexure-2) of children compulsory
and free education under RTE Act 2009 (Annexure-1).
3. School will admit 25% children of backward classes and economical
weaker section in its neighborhood and provide free education till the
completion of elementary education. This Rule will also be applicable
on pre primary education.
4. School will fulfill the requirement for children mentioned in para no.3
of section 12 Sub section 2 of the RTE act and provide separate bank
account for its fulfillment.
5. School will not collect forcibly any fee from any parents or guardian
for any purpose.
6. School will not refuse admission to anyone :-
 - A) Any child who has no birth certificate or
 - B) Any child admitted during extended time for admission
 - C) On the ground of religions, caste creed , birth place.
7. School will ensure :-
 - A) No admitted student can be detained or expelled in any class upto
completion of elementary education.
 - B) No student will subjected to corporal punishment or mental
torture.
 - C) It will not be compulsory for any student to pass any board exam
before completion of elementary education.
 - D) Every student will be issued a certificate after completion of
elementary education.
 - E) Handicapped, in competent or privileged students will admitted
under RTE Act.
 - F) Appointed teacher should have compulsory educational
qualifications. Those teachers already appointed will have to pas
complete their minimum required educational qualifications in 5
years of implementation of RTE Act
 - G) Teachers will perform their duties as mentioned in section 24 and
sub section (1) of the Act.
 - H) Teachers will not indulge themselves in any private tuition.

8. Schools will implement time table and split up syllabus issued by competent administrative organization or authority.
9. School will admit children as per the ration mentioned in art 19 of the Act.
10. School will follow the norms of art 19 of the Act. All facilities mentioned as per previous inspection if existing then are as per the following :-
 - School area (as per report)
 - Total built up area (as per report)
 - Area of play ground (as per report)
 - No of class rooms (as per report)
 - Room of headmaster cum officer (as per report)
 - Availability of teaching learning material/ sports material/ library books.
11. No unrecognized class will be taught in or out of the school under the same name of the school.
12. School building and structure or play grounds will be used only and only for academic activities and skills development.
13. School should have been running by registered society under act no. 21 of 1860 act or by any public organization for time being.
14. School should not being run the benefit of any individual class or alliance
15. School fund accounts should have been checked by registered accountant/ CA and ledger of accounts should have been maintained as per rules. Copy of school fund account will be submitted to District Education Officer (Elementary education) for information.
16. The recognition certificate no of your school is as mentioned above. (It may please be noted for reference of any future correspondence.
17. School will submit all reports and information from time to time to District Education Officer of Director Education Department and will be bound to provide information as directed by State Govt. or Local Administration. All deficiencies removed by school compulsorily required for registration will be submitted.
18. It is would be ensured that registration of school is renewed.
19. Other conditions are attached herewith as annexure 3.

Note : This recognition is issued under the condition that school will submit building safety certificate, fire safety and water testing certificate issued from concerned departments to the undersigned upto 30th April of every year.
